

OLLI at SOU Pacific Flyway Wildlife Tour (Now One-Day Only)

JOIN your fellow OLLI at SOU members **May 17, 2025** on a one-day excursion offered by Main Street Tours of Ashland for a birdwatching and wildlife viewing trip that includes the following:

Itinerary:

- Lower Klamath National Wildlife Refuge;
- Tule Lake National Wildlife Refuge, including its newly built headquarters;
- Lava Beds National Monument; and
- Petroglyph Point.

Guide: The trip will be led by Brandon Breen, an ornithologist and writer who has lived in Ashland, Oregon since 2012. Brandon has worked on numerous avian research projects throughout the USA and abroad. Brandon leads backpacking and birding trips for the Sierra Club, Rogue Valley Audubon Society and Main Street Tours.

Fitness Level: Fairly level walking opportunities, 2.0 miles max and 79 feet maximum elevation gain.

Lunch: Bring your own or purchase box lunch \$20.

Departure: This trip will leave Ashland via a Main Street Tours van departing at **9:00 AM**, from the SOU parking **lot 16 next to the Campbell Center**. If you have registered for a lot 16 parking pass you may park there all day.
